CLOVIS CHAMBER OF COMMERCE AUTHORIZATION AGREEMENT FOR DIRECT PAYMENTS (ACH DEBITS) OR CREDIT CARD CHARGES

Please complete this form and return it to the Chamber. The first payment for new members must be paid on receipt of the application with cash, check, Visa or Mastercard plus the \$25 application fee. Renewing members will not incur an application fee. Membership dues will be automatically debited from a checking account or charged to a credit card on a monthly or quarterly basis.

“I (we) hereby authorize the Clovis Chamber of Commerce, hereinafter called (“CHAMBER”), to initiate debit entries/charges to my (our) checking account or credit card indicated below. The debits/charges will occur on or about the 1st of each month for monthly and the first of each third month for quarterly. In the event such account does not have sufficient funds for a monthly payment, the following month the account will be debited/charged for two months, plus a \$15 transaction fee. In the event an account does not have sufficient funds for a quarterly payment, the following month, the account will be debited/charged, plus a \$15 transaction fee. In the event the account has insufficient funds twice in a 12 month period or has been closed, the account will be deemed in default, the remaining balance becomes due immediately and the membership is cancelled until that balance is paid. This authorization shall remain in full force and effect until CHAMBER receives 30-day written notification from member of its termination. If the termination occurs before 12 payments have been completed for the annual membership term, I understand that the remaining balance becomes due immediately. I further authorize the CHAMBER to debit/charge my account for any fees incurred by the CHAMBER as result of delinquency. The prevailing party in any action or proceeding to enforce the terms of this agreement shall be entitled to an award of reasonable attorney’s fees and costs incurred.”
